Student Loan and Cancer Benefits Effective 9/1/18

That's why CTA created and is providing the Student Loan Benefit¹ and Cancer Benefit¹ for CTA members. These benefits will be available at no additional cost to Members enrolled in the CTA-endorsed Voluntary Disability Insurance plans from Standard Insurance Company (The Standard).

New Student Loan Benefit Effective 9/1/18

Active CTA members approved for a Disability claim under the CTA-endorsed Disability Insurance plans with The Standard with a disability date on or after September 1, 2018 who also have an active Student Loan may be eligible for an additional benefit of up to \$200 per month while they remain disabled (maximum benefit \$1,000). Benefits are paid directly to CTA members and can be used to help make student loan payments.

New Cancer Benefit Effective 9/1/18

Active CTA members approved for a Disability claim due to Cancer under the CTA-endorsed Disability Insurance plans with The Standard with a disability date on or after September 1, 2018 may be eligible for an additional benefit of up to \$200 per month while they remain disabled (maximum benefit \$1,000) in addition to their disability benefit from The Standard.

Benefits are paid directly to CTA members and can be used for everyday expenses that health insurance doesn't cover such as rent/mortgage, utilities, groceries or child care.
